

**Memorial Day – May 30, 2022 - PRESS RELEASE in form of Open Letter to Public**  
**From “Barbie & Ken” Cromar of Cedar Hills, Utah**

**BREAKING.....** Do you recognize this famous face below? Why was **John Sullivan** at our house September 2, 2020 days before we were hit by a 75-man SWAT team? 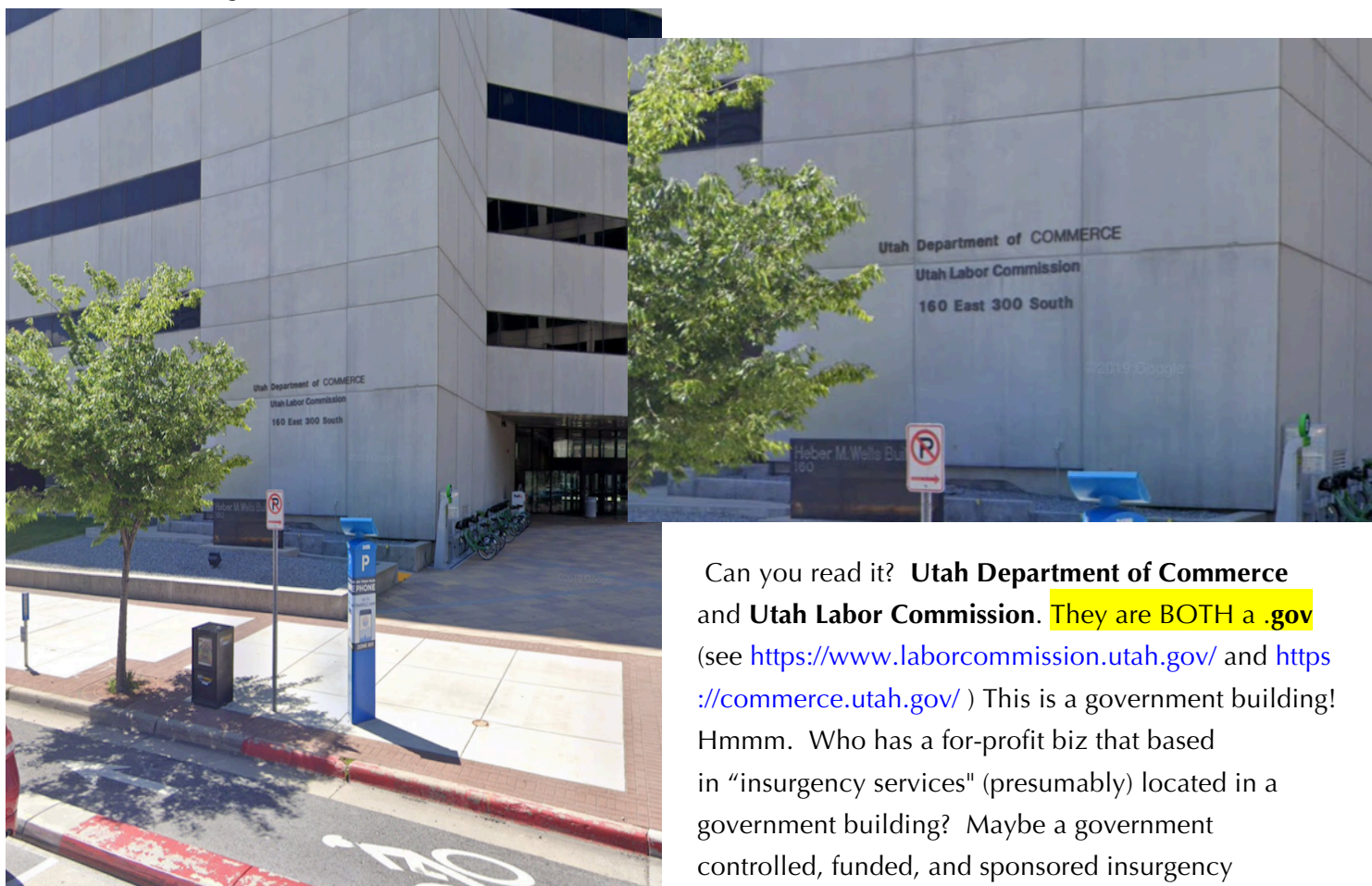

2. Rebelling against the leadership of a political party.

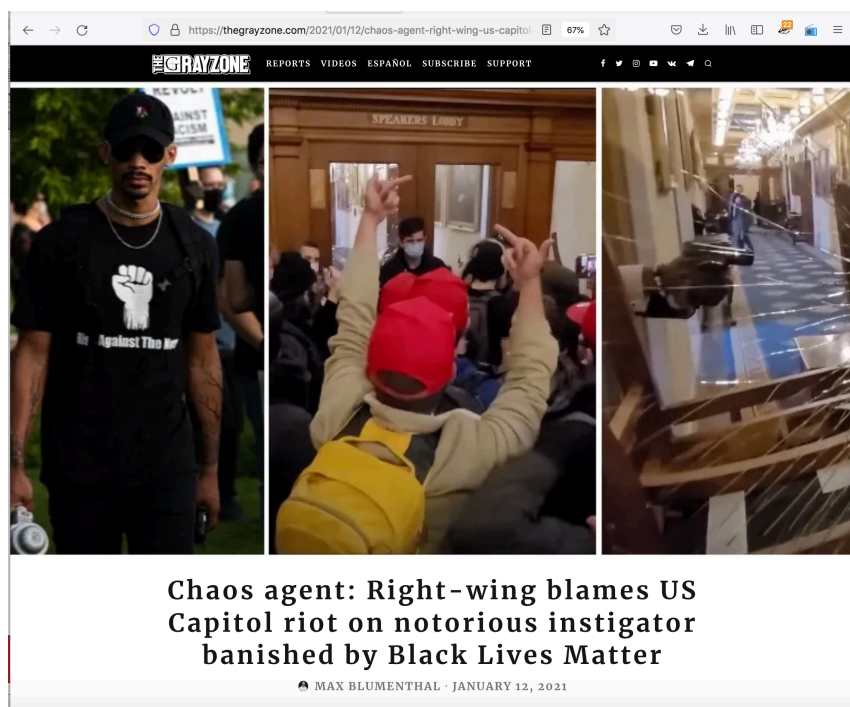

Good. Now you are welcome to come on my property.”* (Note: No one ever admitted to being a government employee or agent – though by law, if they were, they are required to admit it.)

Maybe Mr. Sullivan is innocent? Maybe he’s FBI? Maybe a Soros operative? Utah County Sheriff’s agent? Maybe all the above? Regardless, he was at our home days before we were hit by a 75-man SWAT team — and we would like to know why?
